Audiences

Spending and the arts go hand-inhand. The arts bring economic activity to local businesses through significant amounts of event related spending. This spending is invaluable to local restaurants, hotels, retail stores and the community in general. The numbers below include the theater ticket price.

The Facility

The Johnson study indicates that Elmhurst and the surrounding market area can support a 50,000 sf. building with two distinct theaters and ancillary support areas with an estimated cost of \$25 Million (2018 estimate).

Main theater

- **5**50 seats* theater with fly zone, orchestra pit, control room for sound and light.
- ECPA vision is to split seating with a potential mezzanine level that can be blocked off creating a smaller more intimate space.

*The number of seats was determined by demand, financial, and impact projections. A 1,000+ seat theater would not have the frequency of use at full capacity and theaters smaller than 500-seats present a financial challenge due to the decreased revenue it would have.

Black Box

■ 130 seat convertible space with control room and storage space.

Additional Spaces

- Backstage areas with green rooms for actors and crew
- Lobbies for each space for patron enjoyment
- Administrative offices
- Classrooms for educational purposes and rental opportunities.

Job Creation

- 350 construction jobs generating \$10.1M of total area spending
- Spending leads to \$809K in tax revenues
- Long term, theater presence will add 56 full time jobs

Easy Transportation

There is a significant surrounding area population of over 2.5 million residents within a 30-minute drive with excellent train and auto access. There will be significant demand from Chicago and the broader regional area given role that Elmhurst plays in the region.

Over half of Elmhurst's population over 25 years old (59.1%) hold a Bachelor's degree or higher, compared

to 33.2% in Illinois. A strong correlation exists nationally

between education level and performing arts attendance.



Highly Educated

Disposable Income Elmhurst's significant median household income of nearly \$100,000, indicates disposable income is available for non-essential items and activities, including arts and entertainment. Household income is a key predictor of art's participation. Elmhurst's higher median household income paired with a very involved community in the arts seems to be the quintessential population base for supporting a performing arts center.



Nearly 55% of Elmhurst residents are between the ages of 25-64. As a population tends older, the consumption of arts based offerings increases.

Other fun facts

There are over 28 theater arts, dance and comedy groups in Elmhurst and the surrounding area who perform outside of Elmhurst or in churches, schools and bars. There is an undeniable need for ECPA.

Americas for the Arts study showed students with 4 years of art or music in high school score 100+ points higher on their SAT.

Already established parking lots and restaurants in Elmhurst City Centre make for a perfect experience for theater patrons.

Support within the community for a state-of-the-arts performing arts center has been overwhelming.
